Any objections received by the Clerk's Office will be reviewed and filed.

Upon expiration of the 30-day posting period described above, the Clerk's Office will file an affidavit stating the listing of sealed criminal court records eligible for destruction has been public posted. If no objections are received, the Clerk's Office will state in the affidavit that no objections have been received.

If any objection is filed, the objection will be scheduled for hearing before the Chief Judge, or Chief Judge's designee. The Clerk's Office will notice the objecting party of the hearing on the objection. The Clerk's Office will also post a notice of hearing in the lobby of the Seminole County Criminal Justice Center, and on the Clerk's website (www.seminoleclerk.org) for a period of no less than 10 days prior to the scheduled hearing date and time. Upon the expiration of the 10-day posting for the notice of hearing, the Clerk's Office will file an affidavit stating that notice of hearing has been publicly posted as described in this section.
